PokerEduManager is committed to protecting your privacy and developing technology that gives you the most powerful and safe online experience. This Statement of Privacy applies to the PokerEduManager Web site, PokerEduManager Products and governs data collection and usage. By either using the PokerEduManager website or any of PokerEduManager's products, you consent to the data practices described in this statement.

Collection of your Personal Information

PokerEduManager collects personally identifiable information. PokerEduManager also collects anonymous demographic information, which is not unique to you.

There is also information about your computer hardware and software that is automatically collected by PokerEduManager. This information can include: your IP address, browser type, domain names, access times and referring Web site addresses. This information is used by PokerEduManager for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the PokerEduManager Web site.

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through PokerEduManager public message boards, this information may be collected and used by others. Note: PokerEduManager does not read any of your private communications.

PokerEduManager encourages you to review the privacy statements of Web sites you choose to link to from PokerEduManager so that you can understand how those Web sites collect, use and share your information. PokerEduManager is not responsible for the privacy statements or other content on Web sites outside of the PokerEduManager and PokerEduManager family of Web sites.

Use of your Personal Information

PokerEduManager collects and uses your personal information to operate the PokerEduManager Web site and deliver the services you have requested. PokerEduManager also uses your

personally identifiable information to inform you of other products or services available from PokerEduManager and its affiliates. PokerEduManager may also contact you via surveys to conduct research about your opinion of current services or of potential new services that may be offered.

PokerEduManager does not sell, rent or lease its customer lists to third parties. PokerEduManager may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is not transferred to the third party. In addition, PokerEduManager may share data with trusted partners to help us perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to PokerEduManager, and they are required to maintain the confidentiality of your information.

PokerEduManager does not use or disclose sensitive personal information, such as race, religion, or political affiliations, without your explicit consent.

PokerEduManager keeps track of the Web sites and pages our customers visit within PokerEduManager, in order to determine what PokerEduManager services are the most popular. This data is used to deliver customized content and advertising within PokerEduManager to customers whose behavior indicates that they are interested in a particular subject area.

PokerEduManager Web sites will disclose your personal information, without notice, only if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on PokerEduManager or the site; (b) protect and defend the rights or property of PokerEduManager; and, (c) act under exigent circumstances to protect the personal safety of users of PokerEduManager, or the public.

Use of Cookies

The PokerEduManager Web site use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a Web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. For

example, if you personalize PokerEduManager pages, or register with PokerEduManager site or services, a cookie helps PokerEduManager to recall your specific information on subsequent visits. This simplifies the process of recording your personal information, such as billing addresses, shipping addresses, and so on. When you return to the same PokerEduManager Web site, the information you previously provided can be retrieved, so you can easily use the PokerEduManager features that you customized.

You have the ability to accept or decline cookies. Most Web browsers automatically accept cookies, but you can usually modify your browser setting to decline cookies if you prefer. If you choose to decline cookies, you may not be able to fully experience the interactive features of the PokerEduManager services or Web sites you visit.

Security of your Personal Information

PokerEduManager secures your personal information from unauthorized access, use or disclosure. PokerEduManager secures the personally identifiable information you provide on computer servers in a controlled, secure environment, protected from unauthorized access, use or disclosure. When personal information (such as a credit card number) is transmitted to other Web sites, it is protected through the use of encryption, such as the Secure Socket Layer (SSL) protocol.

PokerEduManager will occasionally update this Statement of Privacy to reflect company and customer feedback. PokerEduManager encourages you to periodically review this Statement to be informed of how PokerEduManager is protecting your information.
